 and in consideration of the sum of two hundred dollars to me in hand
 paid the receipt whereof is hereby acknowledged have granted bargain
 sold and released and by these presents do grant, bargain sell re-
 lease confirm and convey unto William Lindsey of State and District
 aforesaid all that plantation tract or parcel of land containing sixty
 acres more or less situate, lying, and being in the State and District afo-
 resaid on the South East side of Barton's fork of Tiger River. Beginning
 on a stone in Thos. Barton's line, thence South, twenty-seven. East,
 with said Barton's line, twenty-six chains, seventy-five links, to a rock, by
 a pine in John Holcomb's line, twenty three chains, seventeen links to a
 stake on Littleberry Holcomb's, thence N. fourteen W. Eleven chains to
 a red oak on James West's line thence N. fifteen chains fifty links to a
 dead hickory James Barton's corner thence N. sixty six E. to the begi-
 ning corner. It being the greater part of a tract of land granted to
 Benjamin Barton, and by him conveyed to John Gowen deceased and
 by him bequeathed to his son Winn B. Gowen and by Winn B. Gowen con-
 veyed to John Holcombe and by him conveyed to Thomas Archer. Toget-
 her with all and singular the rights, members hereditaments and appur-
 tinances. To have and to hold all and singular the premises before
 mentioned unto the said William Lindsey his heirs and assigns forever
 and I do hereby bind my self my heirs Executors and administrators to
 warrant and forever defend all and singular the said premises unto
 the said William Lindsey his heirs and assigns against my self my heirs and
 assigns and against every other person or persons whomsoever lawfully
 claiming or to claim the same or any part thereof. In Witness whereof I ha-
