

Common pleas held for the District of Greenville tested the twentieth day of April Eighteen hundred and twenty five at the suit of Edward Croft to me directed commanding me that of the goods and chattles lands and tenements of David barrier to levy the sum of one thousand dollars with interest and costs I have seized and taken of the lands and tenements of the said David barrier all that certain piece parcel and lot of land situate lying and being in the village of Greenville being the same wheras the said David barrier formerly lived and being the North East half of the lot conveyed to William Choice Commissioner in Equity Commencing at a Stake at Elias Roberts Corner and running thence on main Street N. 16 degrees East sixty feet to Stake thence S. twenty four degrees East two hundred and twenty four feet to Stake on Brauns Street thence S. 16. degrees. W. sixty feet to Stake Corner thence North seventy four degrees west two hundred and twenty four feet to the beginning corner. And wheras the said premises with their appertinances since the seizure by me made by virtue of the said writ of Fieri facias before mentioned have been Exposed to sale at public Vendue and purchased by Edward Croft of the district and State aforesaid for the sum of Eleven hundred and twenty dollars being the highest sum that was bidden therefor. Now Know Ye that I James McDaniel Sheriff as aforesaid by virtue of the said writ of Fieri facias aforesaid to me directed and delivered as aforesaid and by virtue of the statute in such Case made and provided and for and in consideration of the said sum of Eleven hundred and twenty dollars to me paid or secured to be paid by the said Edward Croft. the receipt and payment whereof I do hereby acknowledge have granted bargained and sold and by these presents do grant bargain and sell unto the said Edward Croft his heirs and assigns for ever the said tract parcel or lot of land with its appertinances and all the Estate right title & interest which the said David barrier of right had of in and to the same. TO HAVE AND TO HOLD the said piece parcel and lot of land with its appertinances unto the said Edward Croft his heirs and assigns for ever as fully and absolutely as I the said James McDaniel Sheriff might could or ought to grant bargain and sell the same by virtue of the statute aforesaid and the said writ of Fieri facias or otherwise In testimony whereof I have hereunto set my hand and affixed my Seal this the fourteenth day of July eighteen hundred and thirty one signed sealed and delivered in the presence of the subscribing witnesses who saw the erasure of one line and two words made before the Execution thereof.
