 or tract of land containing one hundred & sixty acres be the same more or less  
 situate in the <sup>said</sup> district on both sides of the long branch of Beaver dam Creek  
 waters of Chicheroa River of Saluda River. Beginning on a pine 3x Running N.  
 41 W. 33 E. to a dogwood 3x N. 7 E 10 to a Chest. 3x N. 27 E. 33 to a pine 3x S.  
 60 E 5 to a B. gum 3x S. 10 to a Red C. 3x S. 25 E. 33 Hickory 3x S. 65 E. 7 to a  
 maple 3x S. 10 St. 3x then to the beginning. Being granted to Tho<sup>s</sup> Edwards  
 together with all & singular the above described premises unto the said  
 Joseph Tankersly & his heirs & assigns for ever & I do hereby bind myself  
 my heirs, Executors & administrators to warrant & forever defend all  
 & singular the said premises unto the said Joseph & his heirs from my  
 self & my heirs & from all and singular the said premises unto the  
~~said Joseph & his heirs~~ every other person or persons whomsoever  
 lawfully claiming or to claim the same or any part thereof. In
