The State of South Carolina: - Know all men by these presents that I Robert Clark of Greenville District and State aforesaid for an in consideration of Two hundred dollars to me in hand paid by Thomas Goldsmith of the State & District aforesaid; I have granted bargained sold and released and by these presents do bargain, sell and release unto the said Thomas Goldsmith all that tract or parcel of land containing one hundred acres more or less it being a part of a tract of 300 acres originally granted to Joseph Reed by Pattern bearing date the 7th of May 1792 Recorded in grant Book E. No 5. Page 308 the land to be conveyed begins as follows (viz) beginning at a post oak 3x from the original tract and runs N. 70 E. 31.50 on the old line to a red oak bush from thence N. 20 W. through the said tract 40 chains to a red oak 3x head marked on the wagon Road thence S. 70 W. 16 chains to a stake 3x on the original line, thence on S. 20 line 19 chains to a
