Crowder all that piece parcel or tract of land lying and being in the District of Greenville on the Lick Creek & branch of Enoree River, which land was granted to Hananiah Ray on the first day of December in the year 1819, containing by Estimation six hundred and ninety two acres more or less having such marks boundaries and littings as is laid down in the original plat and also in the deed from James McDaniel to Edmond Waddill a reference being had thereto will more fully shew.
