And the said parties do by these presents, warrant and forever defend all and singular the before mentioned and described lot or piece of land with the appurtenances thereto belonging, unto them the said parties of the second part, and to their successors in office chosen and appointed according to the Statute of the State of South Carolina in such case made and provided, from the claim or claims of them the said parties of the first part their heirs or assigns and from the claim or claims of all persons whatsoever.
