of three hundred & Twenty dollars being the Highest sum that was Bidden

vered as aforesaid and by virtue of the Statute in such cases made

the Estate right title and Interest which the said Joshua Ingraham  
Deceased of right had of in and to the same to have and to hold  
the same piece parcell and tract of Land with its appertaining  
unto the said Eli Baldwin his heirs and assigns forever as fully  
and absolutely as I the said James McDaniel Sheriff as aforesaid  
might could or ought to Grant Bargain and sell the same by  
virtue of the Statute aforesaid and the said writ of fieri facias  
or otherwise in witness whereof I the said James McDaniel Sheriff  
as aforesaid have hereunto set my hand and affixed my seal
