Greenville District ³ That I Daniel Cockrum in the state
of South Carolina in Consideration of the sum of one hundred and
fifty dollars to me paid by Hezekiah Gilbert of Greenville district and state
aforesaid have Granted Bargained Sold and Released and by these presents do Grant Bargain
Sell and Release unto the said Hezekiah Gilbert all that tract or Parcell of land being the
same tract whereon the said Daniel Cockrum now lives being part of a tract of land
originally granted to James West and Deeded by said James West to Hezekiah Cockrum
Conveyed from Hezekiah Cockrum to Daniel Cockrum by Deed of Gift being on the south
side of Reedy Fork waters of Reedy River Beginning on a stake on the original line in a
marsh corner of a piece of land deeded to John Gordain Running from thence down the Marsh
to where it intersects a branch that runs from Isaac Roberts Spring thence down the branch
to the creek thence down the creek until a certain White oak Right in a line with the next
corner a persimmon at the Back of said Daniel Cockrum's Smoke House thence to the begin
-ing containing fifty acres more or less together with all and singular the Rights members
Hereditaments and appertaining to the said premises belonging or in any wise Incident or
appertaining to have and to hold all and singular the premises before mentioned unto the said
Hezekiah Gilbert his heirs and assigns forever and I do hereby bind myself heirs Executors
and Administrators to Warrant and forever defend all and singular the said premises unto the
said Hezekiah Gilbert his heirs and assigns against myself and against every person
whomsoever lawfully claiming or to claim the same or any part thereof Witness my
hand and seal this Twenty fourth day of February in the year of our Lord one thousand eight
hundred and thirty two and in the fifty sixth year of the Independence of the United
States of America
