Know all men by these presents that I William Ioor of Greenville district State aforesaid Physician for and inconsideration of the Sum of four hundred dollars Received by me Savannah Georgia in the year 1815 for a young negro Wench named Bella the property of my Wife Ann Ioor and Children Sold by me to a Mrs McGarvin of Said City and which four hundred dollars was to me in hand paid before the scalling and delivery of these presents the Receipt whereof I do hereby acknowledge have Bargained and sold to John R Mathews trustee of Ann Ioor and Children and by these presents do Bargain Sell and deliver to the Said John R Mathews Trustee as aforesaid as the only Compensation if any there be in my power to make for the above mentioned four hundred dollars arising from the Sale of the above mentioned young Wench Bella the property of my wife Ann Ioor and Children and which money I applied to my own private use all my right and title if any I have to the present and Every future Crop made on the plantation on the Golden Grove owned by my said Wife and Children also all my right to the Corn Fodder Carriage Horses Stock of Every description and also all my Right and title if any I have to Every animate and inanimate thing or things on the Said plantation or appertaining or in any wise or shape belonging thereunto To have and to hold all my Right and title if any I have to the present and Every future Crop to the Corn Fodder Carriage Horses Stock of Every Description and also to Every animate and inanimate thing or things on the Said Golden Grove plantation Belonging to Mrs Ann Ioor and Children and on which they reside or any thing appertaining or in any wise or shape belonging to the Said plantation or which may be made off of it unto the Said John R Mathews trustee as aforesaid his Executors administrators and assigns to his and their only proper use and behoof for Ever In Witness whereof I have hereunto set my hand and Seal dated at Greenville November 7th 1831
