hand paid by John W Hansell of the State and district aforesaid have Granted
Bargained Sold and Released and by these presents do Grant Bargain Sell and Release
unto the Said John W Hansell all that plantation or tract of land containing by
Estimation one hundred acres be the same more or less situate in the district aforesaid
on the Waters of Teds River and Bounded as follows (viz) Beginning on
a Red oak corner thence Southwardly on John Sammons line to a post rock
on the originall line thence along said line Westwardly to a hickery corner
underwoods line thence along said line to said Hansells Red oak corner
thence Hansells line to a hickery corner on a branch thence up the meanders of
said Branch and Hollow to the Beginning Together with all and singular
the rights members Hereditaments and appertinances to the said premises
Belonging or in any wise Incident or appertaining To have and to hold all and
Singular the premises above mentioned unto the Said John W. Hansell his heirs
and assigns forever and I do hereby bind myself my heirs Executors and admini-
strators to Warrant and forever defend all and Singular the premises above
mentioned unto the Said John W Hansell his heirs and assigns forever against
myself my heirs and against Every other person or persons lawfully claiming
