

134 State of South Carolina I Know all men by these presents that I David Greenville district ³ Barnett of the State and district aforesaid for the consideration of one hundred and Seventy dollars to me in hand paid by Elisha Moon of Said district and State have Granted Bargained and Sold and by these presents do Grant Bargain and Sell unto the Said Elisha Moon and his heirs one tract or parcell of land containing one hundred and forty acres be the same more or less and bounded as followeth lying on the Waters of Salludia Beginning on Alexander McHenneys Land an a land formerly Belonging to J. B Payne on the old Tugaloo Road Running to a black Oak corner West to a white oak corner thence North to a black oak corner thence a West course to an oak corner thence South to a stake corner thence South East to a path a conditional line to the ford of the branch thence up the Branch to the old road thence up the old road to the Beginning containing one hundred and forty acres be the same more or less Together With all and Singular the rights members &c determinants and appurtenances unto the Said Elisha Moon his heirs forever and I do hereby bind myself my heirs to Warrant and forever defend the above described land for the use and purpose before mentioned unto the Said Elisha Moon from me and my heirs and every other person or persons whomsoever claiming or to claim any part thereof as witness I hereof set my hand and fixe a my seal this ninth day of January 1833 Signed sealed
