 William Barnett Trustees of the Methodist Episcopal Church Establi-
 shed at Liberty in the district of Greenville and State of South
 Carolina a certain tract or parcel of land on which said meeting
 house now stands Situate in the district aforesaid on the road
 leading from Rutherford N.C. to Merritts Ville S.C. Beginning on
 a rock by the road side thence S 10 E 8 rods to a chestnut B. Thence
 S 80 W 20 rods to a chestnut B. Thence N 10 W 8 rods to the road thence
 N 80 E 20 rods to the beginning corner containing one acre to
 have and to hold the above granted tract or parcel of land
 to them the said Trustees and their Successors in office for the bene-
 fit of said Church forever and We the said William Stewart
 and William Barnett do hereby bind ourselves our heirs and
 assigns forever to warrant and defend the above granted premises
 against ourselves our heirs and assigns and against any other
 person or persons lawfully claiming the same or any part
 thereof reserving the privilege to Christians of other Denomi-
 nations to worship on the said premises when not occupied by
 the Methodist in witness whereof we have hereunto set our hands
 and affixed our seals this tenth day of November in the year
 of our lord one thousand eight hundred and thirty two and
 the fifty sixth year of the Independence of the united States
