

South Carolina To all to Whom these presents Shall come I William Blasingame Sheriff of Greenville district and State aforesaid Send Greeting Whereas by virtue of Sundry writs of Habeas Corpus Issued out of the Court of Common Pleas held for the district of Greenville tested the twelfth day of October in the year of our Lord one thousand eight hundred and thirty two at the Suit of George Pile and others to me directed commanding me that of the Goods and Chattels Lands and tenements of H. Montgomery to Levy the Sum of upwards of two hundred dollars Damages and costs I have seized and taken of the lands and tenements of the said Hugh Montgomery all that certain piece parcel and tract of land containing ninety six acres more or less Situate and being in the district of Greenville adjoining Lands of Spartan Goodlett Simon Luster and Robert Nelson for amore particular Reference conveyed from John Dunahoo to the said Hugh Montgomery which will more fully Shew by a plat that is here annexed, and whereas the said premises with their appertinances Since the Seizure by me made by virtue of the said writ of Habeas Corpus before mentioned have been Exposed to Sale at public Vendue and purchased by Robert Nelson Esqr of the district aforesaid for the Sum of thirty two dollars being the highest Sum that was Bidden therefor Now Know ye that I William Blasingame Sheriff aforesaid by virtue of the said writ of Habeas Corpus aforesaid to me directed and delivered as aforesaid and by virtue of the Statute in such case made and provided and for and in consideration of the Sum of thirty two dollars to me in hand paid or Secured to be paid by the said Robert Nelson the receipt and payment whereof I do hereby acknowledge have granted Bargained and Sold and by these presents do Grant Bargain and Sell unto the said Robert Nelson Esqr his heirs and assigns forever the said tract piece and parcel of Land with its appertinances and all the Estate right title and Interest which the said Hugh Montgomery of right had of in unto the same to have and to hold the said piece parcel and tract of land with its appertinances unto the said Robert Nelson his heirs and assigns for ever as fully and absolutely as I the said William Blasingame might could or ought to Grant Bargain and Sell the same by virtue of the Statute aforesaid and the said writ of Habeas Corpus or otherwise in Witness whereof I the said William Blasingame have hereunto set my hand and Seal the eighth day of April in the year of our Lord one thousand eight hundred and thirty three
