Few all that tract or parcel of land it being part of a tract of Land
Which John Mitchel the Husband of the Said Bazilla and the Father of the
Said Doshy Harbin died in possession of in fee Simple the Equal distribution
Share of the Said Doshy Harbin is hereby Intended to be conveyed Situate
Lying and being in the district aforesaid on the Waters of Elisha Thompsons
Beaver Dam Creek Waters of Middle Tyger River Beginning on a chestnut
corner Which is also William Bomers corner running thence a Westwardly
course to a red oak thence With the original line to a black Sack corner
running thence on a dividing line between the Legates an Eastward course
across the Beaverdam creek to an apple corner a conditional corner made
between the Said John Harbin and the Said William Few thence across the
Creek and thence down Said creek on a conditional line to a red oak
corner on William Bomers line this also is a conditional corner thence
along Said Bomers line to the Beginning corner containing fifty acres
be the Same more or less together With all and Singular the rights members
Hereditaments and appurtainances to the Said premises Belonging or in
any wise Incident to have and to hold all and Singular the premises before
mentioned unto the Said William Few his heirs and assigns forever and We do
hereby bind our selves our heirs Executors and administrators to Warrant and
power defend the aforesaid premises unto the Said William Few and his
heirs and assigns against ourselves and our heirs and against every other
person or persons Whomsoever lawfully claiming or to claim the Same
or any part thereof in Witness Whereof We Have hereunto set our hands
