 Send Greeting Whereas by virtue of Sundry Writs of Fieri Facias issued out of  
 The Court of Common Pleas held for the district of Greenville the twelfth  
 day of October in the year of our Lord one thousand Eight hundred and  
 thirty two at the Suit of George Dill and others to me directed command-  
 -ing me that of the Goods and Chattels Lands and Tenements of Hugh  
 Montgomery to levy the Sum of upwards of two hundred dollars Damages  
 and costs I have Seized and taken of the lands and Tenements of the  
 Said Hugh Montgomery all that certain piece parcel and tract of Land  
 containing one hundred and four acres Situate and being in  
 the district of Greenville on both Sides of the State or Columbia Road Lead-  
 -ing leading from ashville North Carolina to Columbia adjoining lands  
 of William Bomer & others for amove particular reference conveyed from  
 Dennis Braine unto the Said Hugh Montgomery as will more fully Shew  
 by a plat that is here annexed and Whereas the Said premises with  
 these appertinances since the Seizure by me made by virtue of the Said  
 Writ of Fieri Facias before mentioned have been Exposed to Sale at Public ven-  
 -due and purchased by James Gidley of the district aforesaid for the Sum  
 of twenty dollars being the highest Sum that was Bidden therefor Now  
 Know Ye that I William Blasingame Sheriff aforesaid by virtue of the  
 Said Writ of Fieri Facias aforesaid to me directed and delivered as afo-  
 -said and by virtue of the Statute in Such Case made and provided  
 and for and Inconsideration of the Said Sum of twenty dollars to me  
 in hand paid or Secured to be paid by the Said James Gidley the Receipt  
 and payment Whereof I do hereby acknowledge have Granted Bargained  
 and Sold and by these presents do Grant Bargain and Sell unto the Said  
 James Gidley his heirs and assigns forever the Said tract piece and par-  
 -cel of Land with its appertinances and all the Estate right title  
 and Interest which the Said Hugh Montgomery of right had of in and  
 to the Same To Have and to hold the Said piece parcel and tract  
 of Land with its appertinances unto the Said James Gidley his  
 heirs and assigns forever as fully and absolutely as I the Said Wm  
 Blasingame might could or ought to Grant Bargain and Sell the  
 Same by virtue of the Statute aforesaid and the Said Writ of Fieri  
 Facias or otherwise In Witness Whereof I the Said William Blasingame  
 have hereunto set my hands and Seal the ninth day of February  
 in the year of our Lord one thousand Eight hundred and thirty
