gton & McBee Streets and running South 74. East three hundred feet to a take
thence North 16 East one hundred and twenty feet to a take corner thence North
74 West on the Dividing line Between Nos 40 & 41. three hundred feet to a take
corner on McBee Street thence along McBee Street one hundred and twenty
feet to the Beginning Together With all and Singular the rights members Herediter-
ments and appurtenances to the Said premises Belonging or in any wise Incident
or appertaining to have and to hold all and Singular the premises before
mentioned unto the Said A. B. Crook his heirs and assigns forever and I do
hereby bind myself my heirs Executors and Administrators to Warrant and
forever defend all and Singular the Said premises unto the Said A. B. Crook
his heirs and assigns against myself and against every other person whomsoever
lawfully claiming or to claim the same or any part thereof witness my
hand and Seal this 11th day of November in the year of our Lord one thousand
Eight hundred and thirty three and in the fifty eighth year of the Independence
of the United States of America }
