 by Perry & Duncan of the district and State aforesaid have granted Bargain
 sold and released and by these presents do Grant Bargain Sell and release
 unto the Said Perry & Duncan all that tract or parcel of Land Situate
 Lying and being in the district and State aforesaid on the North Side of said
 River Beginning at a maple corner on Said river Bank Just below the old ford
 and running North 20. E 25 chains to a post oak thence S 70 E 49.10 chains
 to a stake thence North 29 E 22nd to a large hewn nut thence N 71 W 45 chains
 to a stone thence N 37 W 20 to a post oak thence S 14 W 36.25 chains to a spanish
 oak on the Spring or Still howe Branch thence down Said Branch to Duncan
 Branch thence down Said Duncans Branch to its Entrance into Reedy river
 Thence down Said River with all its Meanderings to the Beginning corner
 containing one hundred and fifty two acres a greater or less to a plat made
