 fully appear by the different conveyances from Joseph Bridges to Benja-
 min Bridges Thomas Edwards and others to Benjamin Bridges Together
 with all and singular the rights members Hereditaments and appurte-
 nances to the said premises belonging or in any wise incident or appur-
 taining to have and to hold all and singular the premises before
 mentioned unto the said Jeremiah Cleveland his heirs and assigns
 forever and we do hereby bind ourselves heirs Executors and administrators to
 to warrant and forever defend all and singular the said premises unto the
 said Jeremiah Cleveland his heirs and assigns against ourselves our
 heirs and against every person whomsoever lawfully claiming or to claim
 the same or any part thereof Witness our hands and seals this the
 second day of November in the year of our Lord one thousand eight hun-
 dred and thirty three and in the fifty seventh year of the Independence
 of the United States of America }

 excepted in this deed about twenty one acres which lies on the South Side
