by these presents do Grant Bargain Sell and release unto the Said Barnett  
Statham acertain tract piece or parcel of Land Situate in Greenville District  
aforesaid on Waters of Ruddy river containing two hundred and twenty nine  
acres it being a part of a tract of Land Conveyed by Joseph Willis and Wife  
to William Thruston & from Said Thruston to Waddy Thompson from Said  
Thompson to William Toney from Said Toney to the aforesaid Edmund Wad-  
dill and the part now to be conveyed from Said Waddill to Said Statham  
and hath such bounds Marks &c as follows (Viz) Beginning at a Black Gum
