

of five hundred dollars to me paid by Rebecca Bradley have Granted Bargained
Sold and released and by these presents do Grant Bargain Sell and Release unto
the Said Rebecka Bradley two tracts of land situate in the district and State aforesaid
one on South Side of Enoree River and the other on Both Sides of Said River
the one on the South Side and where the Widow Miller now lives contains two
hundred and thirty two acres be the same more or less begining at a P. o. 3x
S. 20. E. 74. 30 to R. o 3x thence W. 12. 50 to Stake 37 old line thence N. 60. W. 29 to
R. o 3x thence N. 10. W. 13 ch to R. o 3x thence N. 70. E. 11. 50 to R. o 3x N. 35. E. 3. 50 R. o
3x thence N. 60. W. 39. 50 to a pine 3x thence N. 68. E. 41. chains to the begining the
other tract on Both Sides Said River containing one hundred and twenty
acres more or less begining on a post oak on Edward Bellenger's line or
corner from thence to the head of a branch on Said Bellenger's line to a
Stake 3x from thence a straight course across the little Shoal to R. o on the
South Side of Enoree River from thence down the River to a kickey corner
on Mitchams line from thence along said Mitchams line to a stake corner
from thence to the begining it being part of a tract of five hundred and
Eighty Seven acres originally granted to Edward Bellenger by grant date
14th November 1785 the above described land I do hereby convey to the Said
Rebecka Bradley and to the heirs of her Body together with all and
singular the Rights members Heredeterminents and appertinances there
unto Belonging or in any wise incident or appertaining thereto I do
hereby Bind myself my heirs Executors and Administrators to warrant and for
ever defend the above premises unto the Said Rebecka Bradley and the heirs
of her Body against myself my heirs and every other person whomsoever
lawfully claiming or to claim the same or any part thereof witness my
hand and Seal this 5th February 1834 and in the 58th year of American
Independence
