one thousand eight hundred and thirty four Between John H. I. Service of
Greenville Village in the State aforesaid of the one part and George Gordon
of the City of New York Merchant of the other part Whereas the Said John H.
I. Service in and by a certain obligation or Writing obligatory under his
hand and Seal bearing even date herewith Stands bound unto the Said
George Gordon in the Sum of Four thousand two hundred dollars conditi-
-oned for the payment of two thousand one hundred dollars on the fifteenth
day of February in the year of our Lord one thousand eight hundred and
thirty seven With Lawfull Interest for the Same as in and by the Said
recited obligation and Condition thereof Relation being thereunto had
more fully and at large appears Now this Indenture Witnesseth that the
Said John H. I. Service as well for and in consideration of the aforesaid
Debt or Sum of Two thousand one hundred dollars and for the better
Securing the payment thereof With its Interest unto the Said George
Gordon his Executors administrators and assigns in discharge of the Said
recited obligation as of the further Sum of one dollar to him in hand
paid by the Said George Gordon at and before the Sealling and delivery
hereof the Receipt Whereof is hereby acknowledged hath Granted Barg-
-ained Sold released and confirmed and by these presents doth Grant
Bargain Sell release and confirm unto the Said George Gordon his
heirs and assigns all that Messuage and lot of land Situation in Green-
ville District in the State aforesaid in the North West Square of Said
Village known in the plan of the Village by the Numbers Twenty Eight
Thirty. Thirty two and thirty three Together With all and Singular the
rights members Hereditaments and appurtenances to the Said pre-
mises belonging or in any wise appertaining to have and to hold
the Said Messuage and premises hereby Granted or mentioned or
intended so to be With the appurtenances unto the Said George Gordon
his heirs and assigns to the only proper use and behoof of the Said
George Gordon his heirs and assigns forever Provided always
Nevertheless that if the Said John H. I. Service his heirs Executors or
administrators Shall and do well and truly pay or cause to be paid
unto the Said George Gordon his Executors administrators or assigns
the aforesaid Debt or Sum of two thousand one hundred dollars on the
day and a time herein before mentioned and appointed for payment
thereof With lawfull Interest for the Same according to the condition of
the Said recited obligation Without any fraud or further Delay and
