of North Carolina for and in consideration of the sum of eight  
hundred dollars to me paid by Hugh Stokes of the district and  
State first above mentioned have granted Bargained Sold  
and released and by these presents do grant Bargain Sell and  
release unto the Said Hugh Stokes a certain tract of land situate  
in the district and State first above mentioned on the waters  
of Yeedy River containing one hundred acres it being part of a  
tract of land originally granted to and hath such bounds  
Marks &c as follows (viz) Beginning at a stake 3x on the road  
leading from Greenville about House to Augusta near the  
present residence of Said Stokes thence N. E. 2. E. 25. 75 chs to a  
pine 3x thence N. E. 2. E. 31 chs to a red oak 3x thence S. E. 0. W. 40 chs  
to a stake 3x on the aforesaid road thence down said road S. S. E.  
E. 5. 70 chs to a pine 3x thence S. S. E. 5. 80 to a red oak 3x thence S. S. E.  
E. 19. 70 chs to a P. oak 3x thence S. S. E. 1. 80 chs to the Beginning corner
