assigns forever and I hereby bind myself my heirs Executors administra-
tors to Warrant and forever defend all and singular the said premises
unto the said Mayfield his heirs and assigns against myself my heirs
and against every other person whomsoever lawfully claiming or to claim
the same or any part thereof as witness my hand and seal in the year
of our Lord one thousand eight hundred and thirty two and fifty sixth
year of the American Independence this 22^d day of September 1832
