 Greenville District } of the State and district aforesaid in Consideration  
 of the Sum of four hundred and fifty dollars to me paid by Adam Stennis of  
 the State and district aforesaid have granted Bargained Sold and released  
 and by these presents do Grant Bargain Sell and release unto the said Adam  
 Stennis all that part or parcel of Land being a part of a tract of Land lying  
 and being the aforesaid district on the North side and on the Branches  
 of reedy River Originally Surveyed for and granted to John Buchanan  
 for 640 acres Surveyed by Thomas Lewis on the 21<sup>st</sup> day of May 1784 begin-  
 -ing on a stake near a white oak both marked 3x Thence East 26 Chains  
 802 links to a stake 3x Thence South 38 chains to a stake 3x Thence West 26  
 chains 32 links to a small Hickey 3x Thence North 38 chains to the be-  
 -gining white oak containing one hundred acres together with all  
 and singular the rights members and appertinances to the said  
 premises belonging or in any wise Incident or appertaining to have  
 and to hold all and singular the premises before mentioned unto the  
 said Adam Stennis his heirs and assigns forever and I do hereby  
 bind myself my heirs Executors and administrators to warrant and  
 forever defend all and singular the said premises unto the said  
 Adam Stennis his heirs and assigns against myself and my heirs  
 and against Every other person whomsoever lawfully claiming or to  
 claim the same or any part thereof Witness my hand and seal  
 this twenty seventh day of November one thousand Eight hundred  
 and twenty one and in the forty sixth year of the Independence  
 of the united States of America
