Gantt for their Joint lives and for the lives of the Survivor of them and
the heirs of such Survivor and subject to any Disposition which my
said Wife and Daughter Susannah may think proper to make of
the Land during their lives my Intention being to Give them the absolute
right of ownership over the Land and to do With it as they please
either during their lives and if not Disposed of During the Joint lives
of my said Wife and Daughter then the Survivor to have full right
and power During the lifetime of such Survivor or by her last
will & Testament to make Disposition of the same as she may
