and Inconsideration of the sum of eighteen hundred and fifty dollars
to me paid by William Jacobs of the same place have granted Bargain
sold and released and by these presents do grant Bargain Sell and
Release unto the said William Jacobs all that plantation tract or parcel
of Land Situate in the district aforesaid on both sides of the main
Stream of Brushy Creek and on both sides of the South fork or branch
thereof being the same formerly owned and occupied by Hugh Roarke
Deceased and Conveyed to me by William Choice Commissioner in Equi-
ty and for which I obtained a new Grant dated the 7th day of June
1830 Including a small piece of Vacant Land and containing in the
whole according to the marks & bounds described in the Plat annex-
ed thereto reference being thereto had eight hundred and Sixty
one acres with the exception however of about thirty five acres inclu-
ded within said grant of land already belonging to the said
William Jacobs Together with all and Singular the rights members
Hereditaments and appertaining to the said premises belonging
or in any wise Incident or appertaining To have and to hold all
and Singular the premises before mentioned unto the said William
Jacobs his heirs and assigns forever and I do hereby bind myself my
heirs Executors and Administrators to warrant and forever defend
all and Singular the said premises unto the said William Jacobs
his heirs and assigns against me and my heirs and against
Every person whomsoever lawfully claiming or to claim the same
or any part thereof Witness my hand and Seal this twenty third
day of December in the year of our Lord one thousand eight
hundred and thirty four and in the fifty ninth year of the Independence
of the United States of America
