The State of South Carolina Know all men by these presents that I Josiah Cobb of Greenville district in the State aforesaid farmer in Consideration of one hundred dollars to me in hand paid by Humphrey Cobb of the district and State aforesaid farmer have granted Bargained Sold and released and by these presents do grant Bargain Sell and release unto the said Humphrey Cobb all that part of a tract of two hundred acres of Land lying in the district aforesaid on Mountain Creek waters of Saluda River originally granted to Richard Brown by his Excellency William Moultrie on the 4th day of December 1786 reference being thereto had will more fully appear beginning at a maple on the north fork of Mountain Creek on the original line thence up the Meanders of said Creek 13 chains to a white oak &c at the mouth of a hollow thence the various courses of said hollow along a marked line about 21 chains and a fifty Links to a stake &c thence S.E. 80. 16.50 to black oak &c (Road) thence S.W 15. 46 chains to a red oak &c thence S.E 10. 15 chains to a stake &c old line thence N.W 78. 34 chains to the beginning containing forty eight acres also one other small tract of land lying and being in the district aforesaid on Mountain Creek of Saluda River being part of a tract originally granted Robert Pince on the first day of August 1785 reference being thereto had will more fully appear beginning at a white oak &c on the original line on the north fork of said Creek and running thence S.E. 56. 24.50 to a maple &c thence West 17.50 to a dogwood &c thence up the Meanders of said Creek to the beginning containing twenty five acres Together with all and Singular the rights members &c Determinents and appertainances to the said premises Belonging or in any wise Incident or appertaining to have and to hold all and Singular the premises before mentioned unto the said Humphrey Cobb his heirs and assigns forever and I do hereby bind myself my heirs Executors and administrators to Warrant and forever defend all and Singular the said premises unto the said Humphrey Cobb his heirs and assigns against myself and my heirs and against Every other person Whomsoever lawfully claiming or to claim the same or any part thereof Witness my hand & Seal this tenth day of May one thousand Eight hundred and five and twenty ninth year of American Independence
