 thence S. 39. E. 25 to the Beginning containing fifty acre  
 be the same more or less lying on the waters of Saluda

 and singular the rights members Here determined an  
 appertinances to the said premises or in any way in  
 or appertaining to have and to hold forever and we do  
 hereby bind ourselves our heirs Executors and administrators  
 to warrant and forever defend the said premises unto the  
 said Henry Goal his heirs Executors and administrators  
 from ourselves our heirs and from every other person or pe  
 whomsoever lawfully claiming or to claim the same or an  
 part thereof witness our hands and seals this 5<sup>th</sup> day of  
 November 1834 and fifty Eighth year of the American
