Saluda River containing one hundred acres more or less beginning at
a white oak corner running thence N. 21. W. 20 to a stake thence N. 39 E.
50 chs to a stake thence S. 15. E. 20 to a stake thence S. 39 W. 50 chs to the
beginning corner also one other tract or parcel of land lying in d. district
and State aforesaid granted to Peter Rutledge by Paton bearing date the
4th of December 1804 beginning on a white oak from thence N. E. 50. E. 68 chs
to a stake thence N. 25. E. 30 chs to a stake thence N. 31 W. 30 chs to a stake
thence S. 57. W. 31 to a stake S. 20 chs to a stake S. 15. E. 20 chs to a post or
S. 30 W. 50 chs to the beginning corner containing one hundred &
Eighty nine acres more or less together with all and Singular the
rights members &c determinants and appurtenances to the above
described lands or in any wise appertaining to have and to
hold all and Singular the land and premises before mentioned
unto the said George Southerlin his heirs and assigns forever and
I do hereby bind myself my heirs Executors and Administrators to
warrant and forever defend all and Singular the said premises
unto the said G. Southerlin his heirs and assigns against myself
my heirs and against every other person lawfully claiming or to
claim the same or any part thereof in witness whereof I have
hereunto set my hand and seal this 19th January 1819
