

Running up the left hand side to an ash thence up a branch to a Spanish oak corner thence N. 67. W. 40. 20 to a post oak thence N. 38. W. 25. 30 passing a pine and spring to a black gum thence N. 28. W. 3. 10 to a post oak thence S. 25. E. 25. 70 to a small Black oak thence S. 70. E. 26. 40 to a small Walnut near a pine stump thence S. 80. E. 25. 75 to a stake on Pennington's original line thence S. 43. E. 17. 65 passing a white oak 3 m on fence row to a stake on a ditch being the Golden Grove Creek and thence down the said ditch or Golden Grove Creek to the Beginning as will more fully appear by reference to the plat made by John Watson Esquire deputy Surveyor dated the twenty fifth day of July one thousand eight hundred and thirty four and which is annexed to a deed made by John H. Thompson and others to said Jeremiah Cleveland together with all and singular the rights members Hereditaments & appertinances to the said one fifth part of the said tract of land belonging or in any wise incident or appertaining to have and to hold the said one fifth of the said tract of land and of the rights members Hereditaments and appertinances to the same belonging unto the said Jeremiah Cleveland his heirs and assigns forever and we do hereby give ourselves his Executors Administrators and assigns firmly by these presents to warrant and for ever defend all the right title and Interest that we now have or may hereafter have to the above mentioned one fifth of said tract of land unto the said Jeremiah Cleveland and his heirs forever against ourselves and our heirs and against every other person or persons whomsoever claiming or to claim the said one fifth of the said tract of land or any part of the said one fifth which we claim under the will of the said Josiah Thompson Deceased In W.
