of Greenville District Peden son and wife Rebecca Peden his wife
both of the State and District aforesaid witnesseth that in consideration of the
sum of Four Hundred and Thirty seven dollars to us in hand paid by said -
Peden of the State and District aforesaid have granted bargained sold and
conveyed and do by these presents grant bargain sell release and convey unto the said
Samuel Ramsey his heirs and assigns Esqrs and Attst. a Tract of Land laying
in the State and District aforesaid on Reedy River on the north side River
being a part of tract of Land originally granted to John Wimber for 640 acres
at the same more or less on the 16th day of July 1784 and granted us auct Boston
A. A. R. Day of thence conveyed through several hands to said Alexander Peden
Esqrs from said Alexander Peden to witness Ramsey by virtue Taxt of Land
Beginning at a Rocking marsh & X in original line near the head of a Spring
branch thence south to the river thence up the meadows of said Spring Branch
to the mouth of said Spring Branch thence up the meadow of said Spring Branch
to the beginning corner includes one hundred and four acres to the river
more or less and including the houses and plantations where the said Ramsey
now resides together with all and singular the rights members and appurtenances
to the said premises belonging or in anywise appertaining to have and to hold
all and singular the Rights premises before mentioned unto the said auct
Ramsey his heirs and assigns forever in fullness and the said Alexander Peden
Peden son and Rebecca his wife for themselves and for their heirs to come
Eccor and dauro the said bargained premises well and shall for ever
warrant and defend the right and title therof to the said Samuel Ramsey to
his heirs and assigns free from the Claims or Claims of all persons whatsoever
In testimony whereof the said Alexander Peden and Rebecca Peden
have set our hands and affixed our seals this the Eleventh day of April
in Year of our Lord one thousand eight hundred and thirty six and in
the eighteenth year of the American Independence.
