I James McDaniel Sheriff of Greenville District and State aforesaid send Greeting
Whereas by virtue of Summa writ of Fieri Facias issued out of the court of Common
Please held for the district of Greenville tested the Fall Term 1836 in the year of our
Lord one thousand eight hundred and twenty six at the suit of R. J. Perry
and Nathan Berry Separate Suits to me directed commanding me that of the Goods
and Chattels Lands and Instruments of John Clark to levy the sum of forty dollars
damages and costs I have seized and taken of the same and Instruments of
the said John Clark all the certain Price parcel and tract of Land contain-
ing one Hundred and Eleven acres situate and lying in the district
of Greenville on the waters of Reedy River as follows viz unto Lands
of Joseph McCallough it being the same tract and parcel of Land wherein
the defendant John Clark lives and whereat the said premises with their
appurtenances since the seizure by me made by virtue of the said writ of Fieri
Facias before mentioned have been exposed to sale at public auction and purch-
ased by Michael Thompson of the District of Lawrence for the sum of fifteen
dollars being the highest sum was bid therefore Now Know ye that
I James McDaniel Sheriff aforesaid by virtue of the said writ Fieri Facias
aforesaid to me directed aforesaid delivered to aforesaid and by virtue of the
Statute in such case made and provided and for and in consideration
of the sum of fifteen dollars to me in hand paid or secured
to be paid by the said Michael Thompson the receipt and payment
whereof I do hereby acknowledge have granted bargained and sold
aforesaid to me granted Bargain and sell into the said Michael Thompson his
heirs and assigns forever the said tract piece and parcel of land with
its appurtenances and all the estate right title and interest which the
said John Clark of right of in and to the same do have and to
hold the said piece parcel and tract of Land with its appurtenances
unto the said Michael Thompson his heirs and assigns forever as fully
and absolutely as I the said James McDaniel might could or ought
to grant Bargain and all the same by virtue of the Statute aforesaid
and the said writ of Fieri Facias or other wise. In Witness whereof I
the said James McDaniel have hereunto set my hand and seal this fifth
day of July in the Year of our Lord one thousand eight hundred and
thirty six signed sealed and delivered in presence of
