by my solely and suffrally the proceeds of the labour, hire and
wages of the said negroes so long as she may live and secondly to
use & sole benefit (after her death) of her Children & issue of
(body living) at her death and thirdly Should any beloved
Sarah to Janey die without children or issue of her body
at her death then to the use and benefit of me and my
wife for ever and to no other uses whatsoever, And I the said Will
m L Janey do hereby warrant and for ever defend all and
singular the said Negroes to wit, Dinah & her Children, Jane George
George & Binah and Lavinia and her Children Caroline, Charity,
Jah & Nancy, and George and her child Betsy and their issue
to the said Samuel G Earle his heirs and assigns, in manner and
and for the uses and purposes above mentioned, against my heirs
seculo Administrators and assigns, and against all persons
desirous lawfully or attempting to obtain the same.

day of November in the year of our Lord one thousand eight hundred
and thirty five, and in the Society first year of the Sovereignty and
