South Carolina, Know all men by these presents, That I Vardry M Bee of  
Greenville district 3 Greenville, District in the State aforesaid in consideration  
of the sum of one hundred and fifty dollars to me paid by Joseph Powell  
of the Village of Greenville in the State aforesaid have granted bargained  
Sold and released and by these presents do grant bargain sell and release  
unto the said Joseph Powell All That Lot of land in and adjoining  
the Village of Greenville Beginning at a stake on a cross street forty  
wide & runs South 74 degrees East along a line of the street leading  
from the Baptist Church 385 ~~xxxxxx~~ feet to a line of General Thompson  
Land thence North 22 degrees West 340 feet to a stake near the said Thomp-  
son's fence thence North 74 degrees West along a line of Washington Street  
to a stake on the same cross street of the beginning thence South 16 deg-  
rees East 340 feet along the cross street to the beginning -

Together with all and singular the Rights, Members, Accretions  
and Appurtenances to the said Premises belonging, or in anywise  
incident or appertaining; To have and To hold all and singu-  
lar the Premises beforementioned, unto the said Joseph Powell his  
Heirs and Assigns forever And I do hereby bind myself and my He-  
irs and against every person whomsoever, lawfully claiming or to claim  
the same or any part thereof
