sold and released and by these presents do grant bargain sell and release unto
the said Matthew E Cunningham all that tract or parcel of land containing 16 acres
more or less situate in Greenville District on a branch of Sullards Creek of Edora
River Beginning at a rock in Georgia Road thence along said road N 20 E
2 chains to where Mr E Cunningham's line crosses said road thence on said
Cunningham's line N 75 W 13 ch 75 links to small persimmons 3x on bank of bran-
ch thence up the meander of said branch to an ash 3x near where the road leading
from said Mr E Cunningham's to Mr Westmorelands Mill crosses said branch thence
along said branch mill road to beginning on lands of my own. Together with all and
the rights members hereditaments and appurtenances to the said premises belong-
ing or in anywise incident or appertaining. To have and to hold all and singular
parts above described premises to the said Matthew E Cunningham his heirs Execu-
tors Administrators and Assigns forever. And I do hereby bind myself my heirs Execu-
tors Administrators to warrant and forever defend all and singular the said premises
unto the said Matthew E Cunningham his heirs and assigns against myself my
heir, and against every other person or persons whomsoever lawfully claiming onto
