

nevertheless that if the said Bird M Pearson his Executors or Administrators shall well and truly pay or cause to be paid unto the said Edward Croft his certain attorney Executors Administrators or assigns the full and just sum above mentioned, according to the true intent and meaning of the bond and condition thereof aforesaid and of these presents, then this deed of bargain and sale and every clause article and thing therein contained, shall cease, determine, and be utterly void and of none effect; any herein before contained to the contrary thereof in anywise notwithstanding. And it is hereby declared by and between the parties, and the said Bird M Pearson for himself, his Executors, Administrators and assigns doth covenant promise and agree to and with the said Edward Croft his Executors, Administrators and by these presents that if default shall happen to be made of or in payment of the said sum above mentioned according to the true intent and meaning of the said Bond that then and in such case, it shall and may be lawful to and for the said Edward Croft his Executors, Administrators, Assigns, Attornies or Agents, from time to time ~~hereafter~~ any time hereafter peaceably and quietly, to enter into all or any the messuages, lands or tenements of the said Bird M Pearson and to take the whole or any part of the said Negroes into his custody and possession and the same to hold and detain to his own use and behoof (as his own proper goods and chattels) from thence forth and forever, or the same to sell and dispose of at his pleasure; returning the overplus if any should happen to be after paying the sum above mentioned unto the said Bird M Pearson his Executors Administrators or assigns
