for the purpose of indemnifying and saving ~~them~~ the said Vandy, M^r Bee,
B. Durham, Peter Couble, Silas R. Whitten, R. Jordan and William Blasingame
my securities aforesaid, from all danger, risk, damage & liabilities which they
may now be under or which they may hereafter be subjected to as my securities
to the bond above mentioned, and to make them secure against any sum
or sums of money which they may ever have to pay on the said Bond, or their
heirs executors administrators or assigns, I the said David Henning have barg-
ained and sold and by these presents do grant bargain and sell and
in plain open market deliver unto the said Vandy M^r Bee, B. Durham,
Peter Couble, R. Jordan, Silas R. Whitten, and William Blasingame the
following Negroes (viz) Gitter and his wife named Julia, Iron, Phersby,
Elias and Minta and their increase. To have and to hold the said Negroes and
their increase unto the said Vandy, M^r Bee, B. Durham, Peter Couble, R. Jordan,
Silas R. Whitten and William Blasingame their heirs administrators
Executors & assigns Provided Always nevertheless that if the said David Henning
his heirs ¹⁰⁶ executors and administrators shall I do well and truly pay or cause
