 for me towards the payments of my debts as above stated together with the lawful

 of the above & also in consideration of the further sum of Five dollars to me
 in hand well truly paid by the said B. Dunham, Peter boule, Roger Goeland
 & Vardry M. Bee at and before the sealing and delivery of these presents the
 receipt whereof is hereby acknowledged have granted bargained sold & released
 and by these presents do grant bargain sell & release unto the said B. Dunham
 Peter boule, Roger Goeland & Vardry M. Bee the following Lots & parcels of land
 (Viz) The house and lot situated in the Village of Greenville now occupied by
 Jasper Powers as a store fronting on main street containing one quarter of an acre
 fully described in the deed of conveyance to me from R. D. Roeland for the same
 also my lot on which my stables stand being Lot #18 and which is more fully
 described in a deed for the same to me from Vardry M. Bee—also a house and
 lot near the village of Greenville known as the cottage containing Four acres
 and particularly described in a deed from Dr Theodore Grardin to me for
 the same—also Six acres adjoining the above bought of P. E. Duncan and described in
 his deed to me—also twelve acres adjoining the above bought of Edward Brett and
 fully described in his deed to me for the same—Together with all and singular
 the rights members hereditaments and appurtenances to the said premises belonging
 or in anywise incident or appertaining to have & to hold all and singular the said
