Oak Sapling 3 x Thence N. 9 E. 20.50 to the beginning. Together with all and singular the rights members hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining To have and to hold all and singular the above described premises to the said Jeremiah Gilbert his heirs Executors Administrators and assigns forever And I do hereby bind myself my heirs Executors and administrators to warrant and forever defend all and singular the said premises unto the said Jeremiah Gilbert
