 and being the whole and every part and parcel of the tract or tracts owned by
 said Samuel A. Maverick in the place alluded to and adjoining the lands
 owned and occupied by the said Walter Austin Together with all and singular
 the rights Members Hereditaments and Appurtenances to the said premises
 belonging or in anywise incident or appertaining To have and to hold all and
 singular the Premises before mentioned unto the said Walter Austin his Heirs
 and Assigns forever And I do hereby bind myself my Heirs Executors & Administrators
 to warrant and forever defend all and singular the premises unto the said Walter
 Austin and his Heirs and Assigns against myself and my Heirs and against all persons
