the sum of One hundred and forty dollars to me in hand paid by Thos. J. Burton
of the same place have granted bargained sold and released and by these presents
do grant bargain sell and release unto the said Thos. J. Burton all that tract
or parcel of land amounting to twenty eight acres more or less lying and
being in the State and District aforesaid being a part of the tract sold by
Dr. Thomas Alexander of Georgia to said Nabor on the Reedy Fork branches
waters of Reedy River beginning on a large Pine 3x0 m. near a Post Oak 3x
0 m. thence N 62 W 24.50 to a Stake 3x0 m. on the Wilson's Ferry Road. thence
N 87 E 37 along said Road to a Stake 3x1 m. thence S 29 E 7 across a small Bra-
-nch to N. 0 34 0 m. thence N 66 W 2.60 across branch to N. 63 x 0 m. thence S 63 W
19 to Beginning corner and adjoining lands of Vincent Thompson and said
Burton. Together with all and singular the Rights Members Hereditaments
Appurtenances belonging or in any wise incident or appertaining to have
and to hold all and singular the premises before mentioned unto the
said Thomas J. Burton his heirs or assigns forever. And I do hereby bind
myself my heirs Executors and Administrators firmly by these presents
to warrant and forever defend all and singular the premises before men-
tioned unto the said Thos. J. his heirs and Assigns against myself and
every other person or persons whosoever lawfully claiming or to claim
the same or any part thereof witness my hand & seal this 1st of December
1838 signed sealed and delivered in presence
