Greenville District N. W<sup>m</sup> B<sup>r</sup> of the Village of Greenville in the  
State aforesaid in consideration of the sum of Sixty six dollars to  
me paid by I. H. Benedict likewise of the Village of Greenville  
in the State aforesaid have granted, bargained, sold & released  
and by these presents do grant bargain sell and release unto the  
said I. H. Benedict, All that Piece or parcel of land lying  
within the corporation of said Village. Beginning at a stone  
corner of said I. H. Benedict's lot & Run<sup>s</sup> thence South 22 degrees  
West, 108 feet, along a Cross Street which is 50 feet wide, to a  
stone on a Street running by Doctor Austin's Stable. whence along  
that Street South 50 $\frac{1}{2}$  E 184 feet to a stone. thence North 22 East  
58 feet to a stone another corner of said Isaac H. Benedict's  
lot. then with a line of said lot to the Beginning  
Together with all and singular the rights, Members, hereditaments  
and appurtenances to the said Premises belonging, or in any  
wise incident or appertaining: To have and to hold, all and  
singular the Premises before mentioned, unto the said Isaac  
H. Benedict his Heirs and assigns forever. And I do hereby  
bind myself my Heirs, Executors and Administrators to warrant  
and forever defend, all and singular the said Premises unto  
the said I. H. Benedict his Heirs and assigns against  
myself and my Heirs and against every person whomsoever  
lawfully claiming or to claim the same or any part thereof  
Witness my Hand and seal this twenty third day of December  
in the year of our Lord One thousand eight hundred & forty  
and in the fifty fifth year of the Independence of the  
United States of America signed, sealed and delivered in
