 of the estate of the said Hudson Berry dec<sup>d</sup> in consideration  
 of the sum of Three hundred and thirty three dollars to me paid  
 by John Paul of the said State and District aforesaid have granted  
 bargained sold and released and by these presents do grant  
 bargain sell and release unto the said John Paul a plantation  
 and tract of land laying in the State and district aforesaid on  
 the North side of Reddy River it being the tract of land that  
 the above named Hudson Berry bought from Christopher Robbins  
 Beginning on a Maple 3+ on the North Bank of Reddy River  
 thence running N. 50 E. 11 to a Persimmon 3+ thence N. 19 W. 25. 50 to a  
 Post Oak 3+ bounded by George Fullers thence N. 50 E. 15 to a Stake -  
 (formerly a Red Oak near Mt<sup>l</sup> Owen's Spring) thence S. 40 E. 24. 70 to  
 a Red Oak 3+ bounded by John Riddle thence South 24. 70 to a Pine  
 3+. thence S 30. W. 22. 70 to a Stake 3+ thence N. 40. W. 7 to a Stone  
 3+ (in the field) thence S 50 W. 1. 70 to a Stake on the River bank  
 bounded by land that George Paul bought of - (of thence up  
 to meanders of said River to the Beginning containing one  
 hundred and seven acres. Together with all and singular  
 the rights members hereditaments and appurtenances to the  
 said premises belonging or in anywise incident or appertaining  
 to have and to hold all and singular the premises above  
 mentioned unto the said John Paul his heirs and assigns  
 forever. And I do hereby bind myself (as Executor) of the estate
