branch to a small maple 3x thence S 34° E 18 Chas 50 links to a red Oak 3x thence N 62°
E 31 chains to a Poplar 3x on Sassafras Branch thence down the meanders of the
branch to Beaverdam Creek thence up the Creek to the mouth of a branch thence
up the branch to the beginning. Containing One hundred and four acres
be the same more or less. To have and to hold the above granted premises
unto him the said William Bowen his heirs and assigns forever; together
with all and singular the right, members, appurtenances and privileges
