fifty Six Dollars to us paid by A. W. Jones of said District have granted bar-  
gained sold and released, and by these presents do grant bargain sell and release unto  
the said A. W. Jones, all that tract or parcel of Land containing fifty acres more or  
less situate in Brunsville District on a small branch of Enora River beginning at  
A. W. Jones corner a state or Passafra joining Nancy Hughes land 38 thence run-  
ning in A. W. Jones land N 80. E. 57. 30 to a black Oak 38 thence on Robt. W. Blakey  
land S 48. 70. 00 to a black Oak 38 thence S. 58. E. 17. 30 on land of Jonathan  
Davis deceased and land of Nancy Hughes to the beginning state or Passafra together  
with all and singular the rights members, Perquisites and appurtenances to the  
said premises belonging or in any wise incident or appertaining to have and to hold  
all and singular the above described premises to the said A. W. Jones his heirs Executors
