Owen Jenkins } Deed of Sale for 39 Acres of Land

To
 John J Bennet } State of South Carolina } Know all men by these presents
 Greenville District } that I Owen Jenkins Sr
 of District and State aforesaid for and in consideration of the sum of Three
 hundred and ninety Dollars to me paid by John J Bennet of said
 State and District, have granted bargained sold and released and by these
 presents do grant bargain sell and release unto the said John J Bennet
 all that parcel or tract of land containing Thirty nine acres (more or less)
 situate in Greenville District on the north prong of Flat Rock creek
 waters of Reedy River beginning on a dogwood corner 3x thence N. 28. W.
 18. 00 to a black oak 3x on D. H. Jenkins line, thence along Jenkins bridge
 road on John H Harrisons line, N. 76. E. 11. 50. to turn in road thence
 along said road N. 54. E. 5. 15. to stake 3x thence on John H Harrisons
 and John Wasons lines S. 63. E. 21. 00 to red oak 3. thence on Owen Jenkins
 Senr line down branch S. 65. W. 19. 00. to Ash station 3. thence on same
 course 10. 90. to the beginning corner. Together with all and singular the
 rights members hereditaments and appurtenances, to the said premises belong-
 ing or in anywise incident or appertaining. To have and to hold all
 and singular the above described premises unto the said John J Bennet
 his heirs and assigns forever. And I do hereby bind myself my heirs
 executors and administrators to warrant and forever defend the
 premises aforesaid against myself and my heirs and against every other
 person or persons whomsoever lawfully claiming to claim the same or
