Winthrop and Alexander Brown in pursuance and Execution of the said Will, do hereby grant bargain sell and convey unto the said Allen Griffin all that tract piece or parcel of Land situate lying and being on Maple Creek of Reedy River containing One hundred acres more or less beginning at a lightwood stake running thence North bounded by William Kellys line to intersect with James Seaborns line and runs East to a stake thence running to a lightwood stake corner to intersect a line made by the parties which proceed from the beginning To have and to hold, the said premises above described together with all and singular the rights members hereditaments and appurtenances to the same belonging or in anywise incident or appertaining unto the said Allen Griffin his heirs and assigns forever.
