 Greenville District of the State and District aforesaid for and in consideration to me in hand of the sum of Eleven hundred Dollars paid by James Anderson Jr of Spartanburgh District and State aforesaid have granted bargained and sold and by these presents do grant bargain and sell and release unto the said James Anderson Junr all that tract or plantation of land whereon I now live beginning at a small Pine or Stake on Josiah Kilgore's land C. 11. to P. O. 3X. 3X. in the old road thence S. 42. E. 33.50 a white oak bush 3X on land belonging to J. C. Westmoreland thence on said line N. 10. E. to Silders Creek thence down said Creek to possession 3X. & thence N. 35. E. 17.50 to poplar stump thence N. 25. W. 6 to a Beach corner on Enore River thence up the meanders of the River to a willow 3X the corner dividing the lands of George Brynes & John Brynes thence in westerly direction to a poplar 3X in the old field thence to the beginning corner which line is more fully laid down in a deed from John Brynes to James Anderson. Containing One hundred and fifty acres more or less. Together with all and singular the rights members, hereditaments & appurtenances belonging or in anywise incident or appertaining.
