send Greeting, Whereas, by virtue of sundry writs of fieri facias
issued out of the Court of common pleas, held for the District of
Greenville, one tested the second day of November in the Year of our
Lord one thousand eight hundred and forty one at the suit of William
Dorr to me directed, commanding me, that of the goods and chattels, lands

as I the said W Mc Goodlett Shff aforesaid might could or ought
to grant bargain and sell the same by virtue of the statute afore-
