Hinman his heirs & assigns forever, the said tract, piece & parcel of land, with its appurtenances, and all the estate, right title & interest, which the said Charles Garrison of right had of in and to the same, To have and to hold, the said piece, parcel & tract of land, with its appurtenances unto the said P. W. Hinman, his heirs & assigns forever as fully & absolutely as I, myself, the said W<sup>m</sup>. Goodlett, Sheriff aforesaid might, could or ought to grant, bargain and sell the same, by virtue of the Statute aforesaid, and the said Writs of fier facias or otherwise. In obedience to an Act of Congress, presenting the mode of Naturalization the undersigned D. Fraser respectfully reports to the Clerk of the Court of Common Pleas for Greenville District South Carolina that he was born in North Britain in the Kingdom of Great Britain about the Year Eighteen Hundred and ten having no record to records, and owing allegiance to the King of Great Britain that he sailed from the City of Liverpool in September 1836 for the United States that he landed in the City of New York about the 1<sup>st</sup> Nov. 1836 and left for the State of Georgia in March Eighteen Hundred and Thirty seven with a view of residing in the Southern States that he is now about Thirty three Years of age and is desirous
